Ethics & Risk Agreement

I understand that the Colorado Junior Karting Club (the "Club") will be presenting a club racing series and that these classes: Kid Kart, Jr-1 and Jr-2 will be using current IKF rules and the Regional rules of the Club. By signing this agreement, I acknowledge that I understand and/or have been advised of these rules and agree that the equipment I will be using in competition will be within these rules and guidelines. I also understand that it is typical for a racing event to require a post race technical inspection of any and/or all pieces of racing equipment and related items. Whether it is during one of these typical inspections or for any reason my equipment is suspect, I agree to submit any and all equipment for inspection by any person or party as designated by the Club. I also agree to accept the decision of the Club resulting from such inspection. I accept all rulings/actions made by the Club officials as final, and that no further action, legal or otherwise, may be taken by me against either the Club or the IKF. I also understand that racing is inherently dangerous and may result in injury or even death. In any and all cases I agree to hold harmless and release and covenant not to sue any and all members, the Club, participants, organizers, racers, volunteers, sponsors, tracks and officials FROM ANY AND ALL CLAIMS, LOSSES OR DAMAGES, OF MYSELF OR MY MINOR CHILD, RESULTING DIRECTLY OR INDIRECTLY FROM THE ACTIONS OR NEGLIGENCE OF THE CLUB OR PARTIES LISTED ABOVE.
